

AN ORDINANCE TO AMEND THE ZONING MAP AND ZONING
ORDINANCE OF THE CITY OF MORGANFIELD, KENTUCKY,
OF DECEMBER, 1960.

The City Council of the City of Morganfield, Kentucky does
ordain as follows:

The Zoning Map dated December 8, 1960 is hereby amended in the
following respects:

(1) The I-1 district is hereby enlarged so that it shall
include the property of Donald French located at the cor-
ner of Waverly and North Morgan Streets, said property
being bounded by said streets and also bounded by E.S.
Wilson on the North and by the property of Berry and
Wilson on the West.

(2) That the I-1 district is further enlarged to include
the R-2 district marked on the Zoning Map adjacent to the
Odd Fellows Cemetery, located on the Uniontown Road, or
Ky. Highway 130.

(3) Section 71.31 of the Zoning Ordinance is amended to
read as follows:

Dwelling units, boarding and rooming houses, hotels,
motels and house trailer courts or parks, except that dwell-
ing units in existence as of December 8, 1960 may be
altered as provided in R-2 districts.

The public hearing on the foregoing Ordinance shall be held by the
City Council at its next regular meeting date on Thursday, January
10, 1962 at the City Hall at 7:15 P.M. All interested citizens
are cordially invited to attend.

In response to an inquiry by Texas Gas Transmission Corporation, the City of Morganfield hereby agrees to sponsor an industrial bond issue in the amount of \$400,000.00 for the purpose of providing a site and a building for an electronics manufacturer recommended by said Texas Gas Transmission Corporation.

It is further understood that the cost of said bond issue will be amortized over a period of 20 years under a lease rental agreement with said company, and that an agreement will be entered into with said company for a rental arrangement, if desired, at the conclusion of the 20 year period.
