

OIL STREET ORDINANCE

At a regular meeting of the City Council of Morganfield, Kentucky, held in the City Hall at eight (8) o'clock P.M., Friday, June 5th, 1936, the following resolution was, pursuant to Section 2741e-2 Kentucky Statutes, unanimously adopted by the City Council, which resolution relates and authorizes the oiling of certain streets and sections of streets within the limits of Morganfield, Kentucky, said resolution is in words and figures as follows, to-wit-----

WHEREAS, the City Council of Morganfield, Kentucky, deems it to be to the best interests of the general public and will be conducive to the public health that certain streets and sections of streets within the City of Morganfield be oiled at the expense of property owners whose property borders or abuts on such hereinafter designated streets and sections of streets, and as authorized by Section 2741e-2, Section 2741e-3, and Section 2741e-4 Kentucky Statutes.

BE IT THEREFORE resolved by the City Council of Morganfield, Kentucky, that the following streets and sections of streets within the said city be oiled at the expense of property owners whose property borders or abuts upon such hereinafter named streets and sections of streets namely:

MORTON STREET from TOWNSEND STREET to CARRIER STREET.

BRADY STREET from McELROY STREET to north yardline of residence of the Alhorn Estate.

MANNING STREET from BRADY STREET to MART STREET.

O'BANNON STREET from SOUTH MORGAN STREET to POPLAR ALLEY.

SPALDING STREET from SOUTH MORGAN STREET to west side of CHURCH ST.

CHURCH STREET from SPALDING STREET to GEIGER STREET.

GEIGER STREET from SOUTH MORGAN STREET to CHURCH STREET.

SPRING ALLEY from McELROY STREET to MAIN STREET.

NORTH COURT STREET from AIRLINE ROAD to north side of WAVERLY ST.

DELANEY STREET from MAIN STREET to McELROY STREET

TOWNSEND STREET from MAIN STREET to AIRLINE ROAD.

WEST McELROY STREET from west end of brick pavement to west side of ROBERTS STREET.

ROBERTS STREET from MAIN STREET to McELROY STREET.

MART STREET to back drive-way of C.B. Graves property.

NORTH MORGAN STREET from U.S. HIGHWAY #60 to north side of City Limits.

WAVERLY STREET from AIRLINE ROAD to East side of N. MORGAN STREET.

HOUSTON STREET from U.S. HIGHWAY #60 to BRADY STREET.

LYON STREET from U.S. HIGHWAY #60 to East side of BRADY STREET.

BEAVER-DAM ROAD from NORTH MORGAN STREET to west side of Alley back of the J.C. Inge property.

HARRIS STREET from MORTON STREET to HOUSTON STREET.

The foregoing resolution was unanimously adopted and approved, the vote of each councilman being as follows:
