

AN ORDINANCE RELATING TO THE CLOSING OF BRADY OR DELANEY STREET SOUTH OF O'BANNON STREET.

Pursuant to Kentucky Revised Statutes, Section 94.360, it is hereby ordained by the City Council of the City of Morganfield, Kentucky, that a public street located in Morganfield, Kentucky, heretofore known as Brady or Delaney Street, south of O'Bannon Street, and adjacent to the property of A.B. Davis and Thelma Davis, his wife, and Clarence Thomas and Faye Thomas, his wife, be and the same is hereby ordered closed.

Said street is indicated on the plat of the City of Morganfield, recorded at page 1 in the year 1811.

The property adjacent to the said street is as follows:

A.B. Davis and Thelma Davis, his wife and

Clarence Thomas and Faye Thomas, his wife.

Said street is hereby ordered to be closed pursuant to the request of all property owners located adjacent thereto and pursuant to Section 94.360 of the Kentucky Revised Statutes.

A drawing of said street is attached hereto, and made a part of this ordinance as if copied herein in full.

RESOLUTION

RESOLUTION OF THE CITY OF MORGANFIELD, KENTUCKY, RELATING TO THE BLACKTOPPING OF WEST O'BANNON, BEGINNING AT THE WEST INTERSECTION OF JEFFERY'S STREET AND EXTENDING WESTWARDLY TO CHAPMAN ROAD.

Be it resolved by the City Council of the City of Morganfield, Kentucky, as follows:

WHEREAS, it is deemed necessary by the City Council of the City of Morganfield, Kentucky, that a certain street should be improved, and,

WHEREAS, the City Council deems it most advantageous to the City of Morganfield, Kentucky, to the general public and to the property owners benefitted, that a certain street by improved and appropriate assessments for the costs would be charged to the benefitted property owners on a front foot basis as provided by Chapter 94 of the Kentucky Revised Statutes and that said improvements shall constitute a stage improvement.

NOW, THEREFORE, be it resolved that West O'Bannon Street be improved by blacktopping a width of 16 feet beginning at the West intersection of Jefferies Street and extending on West O'Bannon Street to Chapman Road.

Be it further resolved that before said blacktopping contract is let, that a final ordinance be passed by said Council of the City of Morganfield and that the abutting property be assessed on the front foot basis at the conclusion of the work and after the apportionment thereof.
